Renewing Your Certification Status

All Oregon State approved HCI letters (Qualified and Certified are valid for 4 years from the date of issue (OAR 333-002-0140 and 333-002-0150). Qualified letters are not renewable for languages that have certification exams available, namely Arabic, Cantonese, Korean, Mandarin, Russian and Spanish. Please note that while there is a Vietnamese certification exam, Vietnamese interpreters can now renew their HCI letters and registry enrollment by completing only their 24 hours of continuing education. Vietnamese interpreters can choose to take their certification exams, but it is not required for Oregon HCI renewal.

Since you are renewing your certification, you are required to complete 24 hours of OHA approved continuing education classes.

All Certified HCI's must complete 24 hours of OHA approved continuing education (CEU):

- Six hours of health care interpreter ethics
- Six hours of interpretation skills
- Twelve hours of any topics approved by the National Board for Certification of Medical Interpreters (NBCMI) or the Certification Commission for Healthcare Interpreters (CCHI)
